Background

 In November, 2010, the Executive Committee approved the AHIRC's request to revise Policy 6.0 (Transplantation of Non-Resident Aliens)

 First step: Update and simplify data collection on organ donors and candidates who are not residents of the United States



Policy 6.2.5: Community Participation

- Policy Language:
 - Each member center which lists nonresident aliens on its Waiting List should establish a mechanism for community participation and review of its candidate acceptance criteria.

Current goal: to promote transparency and public trust in the OPTN



Core Problems with Current Non-Resident Alien Data Collection

- Minimal public "transparency" of practice with current data collection policy
- Programs find themselves in the "immigration business"
- Programs may be unnecessarily hesitant to transplant nonresident aliens for fear audit
- "Under the radar" transplantation may endanger public trust
- Data collection does not permit adequate delineation of individuals who travel to the US for transplant from those who travel to the US for reasons other than transplant



Current Category Definitions in Policy 6.0


- 6.1.1 Non-Resident Alien
 - A non-resident alien is an individual granted permission by the United States Government to enter the United States on a temporary basis as a non-immigrant alien for purposes which include tourism, business, education, medical care, or temporary employment.
- 6.1.2 Domestic, American Candidate or Resident Alien
 - A domestic, American candidate or resident alien is an individual who is either an American citizen or is an immigrant alien granted permanent resident status by the United States Government or any individual, regardless of immigrant status, qualified for health care entitlement funds from state or federal government sources.

2008: Total of 7,990 deceased donors, 21,748 deceased donor transplants, 6,218 living donors 2009: Total of 8,022 deceased donors, 21,855 deceased donor transplants, 6,610 living donors 2010: Total of 7,944 deceased donors, 22,104 deceased donor transplants, 6,564 living donors




Country of Residence for Non-Resident Alien Deceased Donors 2006-2010






Non-U.S. Citizen Waiting List Registrations Added 2001-2010

How do we Promote Transparency?

- Modify the citizenship field in the deceased donor registration (DDR), living donor registration (LDR), and transplant candidate registration (TCR) forms to:
 - Differentiate between those candidates and donors who are residents of the United States from those who traveled here for the purpose of transplant
 - Residents are potential contributors to the donor pool
- Data collection proposed will not create additional data entry burden to transplant programs, but simply change the list of choices.





Citizenship Field Categories DDR Form

- Current citizenship data field's categories
 - Entry of "non-resident alien" prompts the user to enter the "Home Country"

Proposed Citizenship Categories – DDR Form

- Proposed citizenship categories
 - US Citizen
 - Non-US Citizen/US Resident
 - Non-US Citizen/Non-US Resident

The entry of "Non-US Citizen/Non-US Resident" will prompt the user to enter the home country. Home country is currently collected for "non resident aliens." Therefore, collecting this information for non-US residents will not create additional data entry burden to OPOs.

Intent, Public Comment, and Implementation

Intent

- Update policy, align definitions with proposed data collection
- Modifications to data elements proposed first
- Public comment
 - Not necessary, because no new data collection, but modifications to an existing field in the three forms
- **Implementation**
 - \$16,951 effort is small
 - Require programming in UNetSM but is not anticipated to impact the Chrysalis project
 - Will be implemented with the Tiedi re-write project



Resolution

- **RESOLVED, that the categories in the existing "Citizenship" field in the Living Donor Registration and Transplant Candidate Registration forms be modified as set forth below, pending programming:
 - US Citizen
 - Non-US Citizen/US Resident
 - Non-US Citizen/ Non-US Resident, Traveled to US for Reason Other than Transplant
 - Non-US Citizen/Non-US Resident, Traveled to US for Transplant;
- that the categories in the existing "Citizenship" field in the Deceased Donor Registration form be modified as set forth below, pending programming:
 - US Citizen
 - Non-US Citizen/US Resident
 - Non-US Citizen/ Non-US Resident
- and, that the selection of the "Non-US Citizen/Non-US Resident, Traveled to US for Transplant" category or the "Non-US Citizen/Non-US Resident, Traveled to US for Reason Other than Transplant" category will require the "year of entry to the US," pending programming.

Third bullet: This is currently done when non-resident alien category is selected, but will require programming to maintain this data collection with the modified categories.
