How the geography of organ placement is changing.</p> <p>In the last several years, policy-making committees have proposed changes in distribution maps for several organs, including the difficult and controversial process of drawing broader distribution boundaries for livers. In the last 15 months, court and government interventions have added new challenges to an already weighted issue. To protect our community-based system, the OPTN Executive Committee has directed changes to policy, and the Board formed a committee to develop a new framework for discussing geography. The Kidney and Pancreas committees have written a concept document as the first step in developing a new geographic distribution by December. Clinical Systems to Address Adherence Barriers: Decrease Late Allograft Rejection for Pediatric Transplant Recipients

This session focuses on two hypotheses:

- Do patient-identified adherence barriers during clinical care predict rejection?
- Does this system improve hard outcomes in the real world (biopsy proven acute cellular and antibody mediated rejection)?

Hypothesis 1: Patient-identified adherence barriers will be among the strongest predictors of future rejection. Hypothesis 2: Clinically-integrated systems to identify and mitigate patient-identified barriers to taking immunosuppression will decrease late acute allograft rejection in our population of pediatric transplant recipients. A review of the barrier assessment utilized, interventions piloted, methods analysis used and measured will show how this program has 10 fewer rejections/100 “active patient-years” compared to prior

Hypothesis 2: Clinically-integrated systems to identify and mitigate patient-identified barriers to taking immunosuppression will decrease late acute allograft rejection in our population of pediatric transplant recipients.
